NEW MODULE CONSTRUCTION an agreement was approved with Wood Bros for the construction of a new cell at the Johnson Canyon Landfill adding an estimated capacity of 1.1 million tons or approximately 6 years of landfill capacity at current disposal rates.

MOVING FORWARD with the Organics Collection and Processing Facility at Crazy Horse as the Initial Study and Negative Declaration was approved by the Board of Directors.

2018 EMPLOYEE SURVEY RESULTS for the second year in a row the results demonstrated a decline in employee morale. Comments within the survey indicated that with the City of Salinas One Year notice to withdrawal from the Authority and the uncertainty of a permanent Salinas area facility is extremely concerning to the employees.


CITY OF SALINAS WITHDRAWAL One Year notice was given to the Authority in December. This notice has halted the process to identify a new project description for Long Term Facility Needs Project. Staff continues to work diligently in establishing programs which includes the new full-scale food waste composting operation at Johnson Canyon, to meet new state mandates and to provide services to all the members of its jurisdiction.

PRELIMINARY BUDGET with the uncertainty of the Agency direction staff presented three budget options identifying different operating scenarios. Option one was a status quo budget with no projected rate increases to solid waste. Option two a budget that identified routing all garbage from the City of Salinas and Northern Monterey County to the Monterey Regional Waste Management District (District), as initially proposed by the City of Salinas in their proposed Memorandum of Understanding for the Authority and the District, with a projected 46% rate increase. Option three a budget that identified the withdrawal of the City of Salinas from SVR that includes closure of the Salinas Transfer Station and termination of all services provided by

the Authority for the City of Salinas with a projected 56% rate increase for the customers of the remaining member agencies. All options include scheduled organics increases.
