RECOMMENDATION

Staff recommends that the Board follow the procedure documented in the Authority Code and elect officers for calendar year 2014.

STRATEGIC PLAN RELATIONSHIP

This agenda item is a routine item and does not relate to the Board's strategic plan.

FISCAL IMPACT

If the Immediate Past President is appointed to the Executive Committee, an additional \$100 per meeting would need to be allocated for the 12 month duration of this transitional appointment.

DISCUSSION & ANALYSIS

The Nominating Committee, appointed at the December 2013 meeting (Cullen and De La Rosa), will provide a recommendation for the 2014 Authority Officers: President, Vice President, and Alternate Vice President.

Election Procedures:

At the Board meeting, the Board President opens nominations for President. The Nominating Committee nominates an individual, with a second provided by another Board Member. When nominations have concluded, the President will close the nomination for President. The President will then be elected by majority vote through a show of hands.

The procedure is then repeated for the office of Vice President and Alternate Vice President.

In the event of a tie vote for any office, the election will be repeated until a majority vote is determined.

<u>Discretional Appointment of Immediate Past President to Executive Committee:</u>

Staff recommends that if this appointment is made, that it be made for one year, following past practice, but with the term ending at the first regular meeting in January, concurrent with following year's election of officers.

BACKGROUND

Section 8 of the Joint Powers Authority Agreement provides for the election by the Authority Board for the office of President, Vice President. The term of office is one year commencing upon election at the regular meeting held in January and ending upon election of a successor. A Board Member may serve as an officer for no more than two consecutive terms. Authority Code Sections 2.01.010 and 2.01.011 specify that each elected Office shall rotate between a representative from the City of Salinas, a south county city (i.e., Gonzales, Greenfield, King City, and Soledad) and the County of Monterey but shall not be from the same member agency's legislative body.

Authority Code Section 2.06.010 provides that the Authority Board may determine from time to time to appoint the Authority's immediate Past President as a fourth member of the Executive Committee, in which case the Board shall specify the term of such appointment.

WHEREAS, he has not only represented his jurisdictions well and faithfully but has also shared his knowledge and experience to ensure judicious actions by the Authority Board for the better interest of all residents of the Salinas Valley; and,

WHEREAS, Mr. Armenta has served the Authority Board as the elected Vice President in 2002, President in 2003 and 2004, Alternate Vice President in 2010, and then again Vice President in 2011 and President in 2012 and 2013; and,

WHEREAS, during his recent leadership as Board President, Director Armenta has supported transparency in Authority actions and activities, lead the Authority through the approval of a new and sustainable revenue model, the innovative closure of the Crazy Horse Landfill with artificial turf, continued efforts to achieve the 75% Diversion Goal by 2015 by furthering discussions for a future Materials Recovery Center that includes a Steam Autoclave Waste Conversion System, the participation in the environmental review/public scoping process for a plasma arch gasification project up until the project was placed on hold due to State legislation, establishment of an Outreach Policy expanding bilingual outreach and creating a Citizens Advisory Group, ending the reliance of revenue from imported waste to fund operations, approval of the 2013-16 Strategic Plan, issuance of the 2014 Revenue Bonds Refunding which ultimately resulted in significant savings for the agency, and provided excellent leadership of the Board; and,

NOW, THEREFORE, BE IT PROCLAIMED that the Salinas Valley Solid Waste Authority hereby recognizes Mr. Fernando L. Armenta for his leadership and dedication and looks forward to his continued service.

DISCUSSION & ANALYSIS

Please refer to the attached financial reports and checks issued report for the month of November for a discussion of the Authority's financial position as of November 30, 2013. Following are highlights of the Authority's financial activity for the month of November.

Results of Operations

For the month of November 2013, FY 2013-14 operating revenue exceeded expenditures by \$407,078. Year to Date operating revenues exceeded expenditures by \$1,147,144.

Revenues

Revenues for the month of November totaled \$1,468,611. The monthly Tipping Fees totaled \$908,682 and year to date totaled \$4,908,543 or 44.1% of the forecasted total of \$11,141,800. As of November 30, after five months of the fiscal year (41.7% of the fiscal year) revenues total \$7,751,074 or 43.0% of the total annual revenues forecast of \$18,029,847.

Operating Expenditures

As of November 30 (41.7% of the fiscal year) year-to-date operating expenditures fotal \$6,603,930. This is 40.7% of the operating budget of \$16,242,955.

Capital Project Expenditures

For the month of November 2013, capital project expenditures totaled \$72,682. \$44,958 of the total was for Crazy Horse Landfill 401/404 improvements. These are improvements required by the State of California.

Claims Checks Issued Report

The Authority's Checks Issued Report for the month of November 2013 is attached for review and acceptance. The November checks issued total \$1,093,559.73 of which \$415,055.14 was paid from the payroll checking account for payroll and payroll related benefits. Attached is a printout summarizing the PMIA portfolio at the end of December. The Authority's LAIF investment of \$6,343,076.51 represents .011% of the PMIA.



RECOMMENDATION

Staff recommends approving a budget transfer and accepting the report.

Regarding the contract award, there is no action required by the Board on construction contracts under \$50,000. However, Authority Code section 3.02.030 states that bidding results from all formal and informal construction projects shall be reported to the Board of Directors at the next regular meeting after the bid opening.

STRATEGIC PLAN RELATIONSHIP

The recommended action helps support the Authority's Goal to "Reduce costs and improve services at the Johnson Canyon Landfill."

FISCAL IMPACT

This project has \$17,297 available as of December 31, 2013 The total cost for the work is estimated at \$99,500. The work involves the placement of over 2,240 linear of pipe and 8 LFG wells. This requires a budget transfer of \$82,203 from project 9503-JC Horizontal Wells which has a remaining budget of \$310,000 to CIP 9501.

DISCUSSION & ANALYSIS

The first Request for Bids were issued on November 13, 2013 with no bids submitted. The second Request for Bids was issued on December 31, 2013 with bids due January 8, 2014. One bid was received with the following result:

Company	Bid
SCS Field Services	\$27,816

SCS Field Services is well qualified to carry out this project. They are a leading environmental firm that has a construction license enabling them to perform construction work. The contract amount falls within the General Manager's authority to award the bid.

BACKGROUND

The Salinas Valley Solid Waste Authority is required to control landfill gas migration. This landfill gas project is important to assure there are sufficient landfill gas wells to extract landfill gas in a controlled manner. As with many projects, SVSWA personnel will manage the construction project using SVSWA employees and equipment as appropriate. The estimated cost savings is about \$57,500. The work involves the construction of eight (8) LFG wells, its collection system, extensive road crossings, and connection to the landfill gas to energy facility and SVSWA flare system.



Rationale

Standard & Poor's Ratings Services assigned its 'A+' long-term rating to the Salinas Valley Solid Waste Authority, Calif.'s series 2014A and 2014B revenue refunding bonds. At the same time, Standard & Poor's affirmed its 'A+' long-term rating and underlying rating (SPUR) on the authority's series 2002 revenue bonds. The outlook is stable.

The ratings are based on our view of the authority's:

- Strong liquidity position,
- · Adoption of a new service fee in fiscal 2014 that is not based on tonnage delivered, and
- Low competition as a result of agreements with members requiring delivery of waste to the authority's facilities.

Partly offsetting the above strengths, in our view, are the authority's:

- Decline in debt service coverage (DSC) during the past three years, though coverage on revenue bonds remains adequate;
- Senior-lien revenue bond debt service that will at first decline but then increase moderately in fiscal 2019 after the planned refunding brings a previously subordinate obligation onto the senior lien; and
- Rate resistance from Monterey County, one of its members, which provided a notice of intent to withdraw from the authority but has since rescinded its notice.

The bonds proceeds will be used to refund the authority's series 2002 bonds and to prepay an installment purchase agreement with the City of Salinas. The authority has \$32.1 million in series 2002 bonds outstanding and \$3.3 million due on the installment purchase agreement.

The bonds are secured by the net revenue of the authority's solid waste system. The series 2014 bonds will not have a reserve fund. A rate covenant requires the authority to generate DSC of at least 1.15x. The authority can issue additional debt if historic net revenue, plus allowances for projected revenue from system expansion and increased rates, provides MADS coverage of at least 1.15x on existing and new debt.

The authority was formed in 1997 through an agreement between the county and cities of Salinas, Gonzales, Greenfield, Soledad, and King City to acquire and manage the landfill assets of each member and manage regional solid waste disposal. The system provides solid waste disposal services to the waste sheds of the cities and the eastern and southern unincorporated areas of Monterey County, covering a population of about 267,000. Each member makes its own arrangements for collection within its service area. Under waste delivery agreements with the authority, members agree to deliver all non-recycled waste to the authority. The service area is a productive agricultural region located about 100 miles south of San Francisco. Median household effective buying income within the county was strong in our view at 114% of the national median in 2012. The county's unemployment rate was 8.8% as of November 2013, compared with the state's rate of 8.3%.

The system has one active landfill (Johnson Canyon), two transfer stations, and three closed landfills. The authority covers post-closure maintenance costs for the three closed landfills on a pay-as-you-go basis. At the current tonnage disposal rate, management projects its active landfill has 29 years of remaining capacity. The authority is also exploring waste conversion technologies that could increase the lifespan of the landfill. The authority sets aside money annually for future closure costs associated with Johnson Canyon.

The authority has experienced flat or declining tonnage in each of the past seven years. In fiscal 2013, 236,521 tons were disposed of at the landfill, up 0.2% from 2012 but down 27% from fiscal 2005. The authority anticipates that tonnage will fall further in fiscal 2015 after a contract with a hauler located outside of the service area expires. South Valley Disposal & Recycling Inc. delivers waste from the cities of Gilroy and Morgan Hill and unincorporated Santa Clara County to the authority under a contract that expires on June 30, 2014. We understand that the authority does not plan to renew the contract, which will lead to a loss of about 80,000 tons of waste and about \$2 million in net revenue (after associated expenses) annually. The authority has instituted a rate increase and plans to cut costs to offset the lost revenue.

The authority generates the largest portion of its revenue from landfill tipping fees, which currently stand at \$67 per ton for contract haulers. The latest increase was 5% in July 2012. On July 1, 2013, the authority began collecting an additional flat annual service charge of \$1.73 million, divided among the members based on prior year tonnage. The charge is collected monthly and is not dependent on waste volume, providing additional revenue stability, in our view. The new charge offsets much of the revenue that the authority anticipates losing from the expiration of the South Valley contract.

The authority has experienced rate resistance in recent years, in our view. In July 2012, the county, which represents about 20% of total tonnage, issued a notice of intention to withdraw from the authority and the waste delivery agreement, citing concerns over the authority's finances, among other reasons. The county rescinded the notices on Dec. 5, 2013 after the authority met certain conditions. These included an agreement by the authority not to raise rates through June 30, 2015 except under unforeseen exigent circumstances, to conduct a regional solid waste study to explore efficiencies with a neighboring district, and to not pursue new waste disposal technologies without the county's approval through June 30, 2015. Under the original agreement establishing the authority, all debt service must be paid or provisions for the payment must be made before a member can withdraw. In addition, the withdrawing member retains financial responsibility for landfill closure, post-closure, and site remediation liabilities based on past waste

deliveries. We believe these provisions partly mitigate the potential financial impact should a member withdraw. And the county's decision to rescind the notice to withdraw reduces risk, in our view. However, we believe the county's initial steps taken to withdraw and the subsequent agreement by the authority to keep rates flat through June 30, 2015 under most circumstances suggest continued rate resistance from the county.

Past rate increases have helped stabilize revenue as tonnage has declined, keeping DSC at an a adequate, though declining, level during the past three years. Operating revenue in fiscal 2013 totaled \$16 million, up 4.6%. Operating expenses, excluding depreciation and non-cash landfill closure expenses, were up 6.9% in fiscal 2013 at \$12.6 million. Net revenue, including net operating income, investment income, and other non-operating income, totaled \$3.4 million in fiscal 2013, providing DSC of 1.24x, as calculated by Standard & Poor's. This is down from 1.34x in fiscal 2012. DSC on all debt, including the subordinate installment purchase agreement, was an adequate 1.09x in fiscal 2013 and 1.17x in fiscal 2012.

The series 2014 issue will refund the series 2002 bonds and the installment purchase agreement with Salinas, essentially combining the two obligations on the senior lien. The authority is structuring the debt with lower payments of about \$1.9 million in fiscal years 2015 through 2017, with debt service rising to \$3.1 million annually in 2019 through 2027 and about \$2.8 million in 2028 through 2032. The authority is projecting strong DSC of 1.7x and higher in fiscal years 2014 through 2018. The projections incorporate the new \$1.73 million flat service fee that began on July 1, 2013, and inflation-based rate increases starting in fiscal 2015. The projections also incorporate the loss of about \$2 million in net revenue starting in fiscal 2015, after the South Valley agreement expires. On the expense side, the authority anticipates cost savings from a new landfill operations contract or from taking operations in-house after the current contract with an outside vendor expires on Dec. 31, 2014. The authority is anticipating additional savings in fiscal 2017, when its current transfer station operations contract expires. If these savings are not achieved, DSC could be lower. However, assuming no decline in expenses from fiscal 2014, based on the authority's revenue projections DSC would still be well above 1x.

The authority's liquidity position is strong, in our view. Unrestricted cash and investments totaled \$8.6 million as of June 30, 2013, representing about 248 days of operating expenses on hand. This is about even with fiscal year-end 2012 results.

The authority's five-year capital improvement plan (CIP) through fiscal 2018 includes about \$6.7 million in projects. The plan covers closure expenses on an inactive landfill, equipment replacement, landfill improvements, and other projects. We understand the authority plans to use ongoing revenue and cash on hand to fund the projects. The authority is also considering relocating its Salinas transfer station, the costs of which are not included in the CIP. According to management, the timing, scope, estimated cost, and funding plan for the project are uncertain.

Outlook

The stable outlook reflects our anticipation that liquidity and DSC will remain stable. Rating stability will partly depend on management of rates and expenses, particularly as series 2014 debt service increases beginning in fiscal 2018. If coverage or liquidity were to fall during the next two years or if the capital plan were to substantially increase, we

could lower the rating. Given the scheduled increase in debt service beginning in fiscal 2018 and the recent rate resistance from the county, we do not anticipate raising the rating during the next two years.
