2014 Elected Officers

Past President Armenta was appointed to serve a one-year term on the Executive Committee.



Recognitions

Director Armenta was recognized for his leadership during his presidency in 2012-2013. Local businesses were recognized for their partnership in the used battery collection program. Karen Fellows from Russ's TV Service in Gonzales and Denise Campos with the Monterey County Free Libraries in Soledad and Greenfield were present to receive their recognition.



2013 Annual Employee Survey

The current survey reflected overall improvements from last year's survey in areas such as employee morale and satisfaction towards their jobs and various aspects of the agency. Management will continue to strive to improve employee morale and maintain the Authority's stance of being one of the best placed to work in Monterey County.

Strategic Plan Update

The management team presented an update on the current six-month objectives in preparation for the February 13 strategic planning retreat. The Board commended staff for completing the goal to refinance the revenue bonds.

- A. Fund and implement 75% diversion of waste from landfills (5 objectives: 1 completed/3 delayed/1 on target)
- B. Complete development of the Salinas Area Station and Material Recovery Center (3 objectives delayed)
- C. Utilize closed landfills to generate revenue (5 objectives: 3 completed/2 delayed)
- D. Increase public access, involvement and awareness of Authority activities (6 objectives completed)
- E. Reduce costs and improve services at the Johnson Canyon Landfill (4 objectives: 1 completed/3 delayed)

Closed Landfills Revenue Generating Options

The concepts introduced were solar projects, recreational open space, and storage accommodations for most of the properties and specific concepts such as agricultural uses at Jolon Road and a swap meet at Crazy Horse. The Board asked staff to look at the cost to have a consultant develop recommendations and involve the Citizens Advisory Group for input.

Standard & Poor's Rating on 2014 Refunding Bonds

S&P's rating report gave the Authority an A+ rating with a stable outlook. Staff announced that with the restructure of the bonds, staff was able to utilize the \$2.8 million of reserves in the old bond to pay down 10% of the new bond principal. Also the payment to the City of Salinas will be completed sooner than originally planned and staff was able to purchase bond insurance, which increased the agency's rating to AA-.








Job Attitude









Do you know the Mission, Vision and Goals of the Authority



- A green business powered by landfill gas
