

UPDATE ON ASSEMBLY BILL 939 (AB939) FEE ALLOCATIONS

At the April Board meeting the Board President requested a presentation explaining the detailed AB 939 fee allocations for each member agency. Authority staff compiled and presented at the May meetings a summary on all the programs and services included in the total budget, the allocations for each jurisdiction based on the previous

three years of franchise landfill tonnages in detail, and the extensive public outreach and education activities conducted under AB 939. It was explained that the total budget needed to support AB 939 is \$5.06 million, with \$4.1 million coming from AB 939 Fee contributions and the remainder of the budget being funded through disposal (solid waste) tipping fees or other funding sources. The Board President requested further detail of the costs allocation by jurisdictions to be presented at the June meetings. Authority staff presented the additional requested estimated budget detail information at this meeting.
