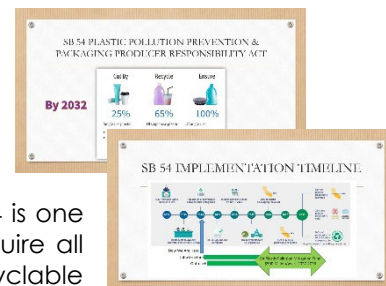




BOARD OF DIRECTORS MEETING HIGHLIGHTS August 15, 2024

LEGISLATIVE UPDATES

A presentation was given to the Board on the new and reviewed legislative and regulatory mandates that could impact the solid waste industry. The legislative work is being done by the Solid Waste Association of North America (SWANA), an organization committed to all things solid waste, recycling, and impacts to the industry. The presentation highlighted some of the most impactful legislation for Extended Producer Responsibility (EPR) Programs. SB 54 is one of the most recent and significant EPR Programs signed into law and will require all single-use packaging and plastic food service ware sold in CA to either be recyclable or compostable by 2032.



ANNUAL TONNAGE AND OPERATIONS REPORT FOR FISCAL YEAR 2023-24

The report demonstrated that materials being processed and vehicle trips at all facilities continue to be steady. For fiscal year 2023-24 the Authority processed a total of 292,925 tons of which 72,195 tons were diverted. Staff detailed the historical landfilled tonnage since 2013 and presented the comparison report for each facility year over year since fiscal year 2015-16 of the trips and tonnage increases.
